APA Citation Style – Quick Reference Guide

The American Psychological Association (APA) has set the following guidelines for citing sources.

A. In a Reference List

A list of your sources should be attached **at the end** of your assignment. Put sources in **alphabetical order**, and **do not number** your list. Use a **hanging indent** (the first line of an entry is not indented, but all the rest are).

It's all in the details! Take note of:

- which words/letters are capitalized?
- which words are italicized?
- placement of punctuation (periods, commas, colons)
- placement of indents

<u>Books</u>

General:

Author, A. A., & Author, B. B. (Date of publication). *Title, only first word capitalized*. City, Province/State: Publisher.

Example:

Calfee, R. C., & Valencia, R. R. (1991). APA guide to preparing manuscripts for journal publication. Washington, DC: American Psychological Association.

<u>Websites</u>

General:

Author, A. A., & Author, B. B. (Date of publication). Title of document. Retrieved from http://Web address

Example:

Angeli, E., Wagner, J., Lawrick, E., Moore, K., Anderson, M., Soderland, L., & Brizee, A. (2010, May 5). General format. Retrieved from http://owl.english.purdue.edu/owl/resource/560/01/

Variations:

- If **no date** is listed, write (n.d.) in place of the year
- If no author is listed, move the title up to the author position, and do not italicize it.

Example:

General format. (n.d.) Retrieved from http://owl.english.purdue.edu/owl/resource/560/01/

B. Internally, in the Body of Your Work

If you are required to cite your sources in-text, you only need to state the author(s) and date of publication, in **parentheses**. Place your citation **immediately following the information** you are citing. For example:

Some of the most complex animal societies on Earth are formed by leaf cutter ants (Ross, 2002).

Scenario	Example
<u>One to two authors</u> - Identify the authors' last names, and year of publication	(Wegener & Petty, 1994)
<u>Three to five authors</u> - Identify the authors' last names and year of publication the <u>first time only</u> . For all	first time: (Kernis, Cornell, Sun, Berry, & Harlow, 1993)
following citations, identify only the first author, followed by "et al.", and year.	<i>subsequent</i> : (Kernis et al., 1993)
Six authors or more - First author only, followed by "et al.", and year.	(Harris et al., 2001)
<u>Author is an organization</u> - Spell out the name of the group, with title case capitalization.	(National Institute of Mental Health, 2005)
<u>Author unknown</u> - If the author is not listed, use the first 1-3 words of the document's title, in quotations.	("Enzyme function", 2013)

These are the most common formats you will need to use.
